### SCHEDULE OF TEAM FINES

The following League Penalty Schedule pertains to players only.

#### OFFENSE

#### FINE

Unexcused absence from scheduled Team regular or post season practice or arriving more than 30 mins late for a scheduled regular or post season Team practice, marketing or media event other than for an emergency or unavoidable delay that is reported to the Team's Front office by the Player at least an hour in advance

\$100 fine  
Increases \$50 per instance

Conduct detrimental to the interests of the Arena Football One (i.e., gambling on a League game, use or sale of illicit narcotics, incarceration for a felony)  
Or physically abusing a member of the Arena Football One staff

Maximum \$1000 fine, plus possible League suspension

Verbally assaulting a member of the Arena Football One League staff, fighting, and/or use of abusive language

1st offense: Maximum \$500 fine, plus possible suspension for one game without pay  
2nd offense: Maximum \$1000 fine, plus mandatory suspension of one game without pay  
3rd offense: Maximum \$2000 fine, plus mandatory suspension of two games without pay

Verbally assaulting an Arena Football One game official or support staff

1st offense: \$100 fine and Written Warning  
2<sup>nd</sup> offense: \$500 fine and possible one game suspension.  
3<sup>rd</sup> offense: \$1000 fine and possible season suspension

Intentionally physically abusing an Arena Football One game official or support staff

1st offense: Maximum \$500 fine, plus mandatory suspension of one games  
2<sup>nd</sup> offense: Maximum \$1000 fine, plus mandatory suspension of three games  
3rd offense: Mandatory suspension for the season from Arena Football One

Entering the official's dressing room without the permission of the Referee

1st offense: Maximum \$2000 fine,  
2nd offense: Maximum \$5000 fine, plus mandatory suspension of one game  
3rd offense: Maximum \$ 10000 fine, plus mandatory

Entering the official's dressing room without the permission of the Referee	1st offense: Maximum \$2000 fine, 2nd offense: Maximum \$5000 fine, plus mandatory suspension of one game 3rd offense: Maximum \$ 10000 fine, plus mandatory suspension of 4 games and possible banishment from Arena Football One
Verbal assault / abuse of a spectator	1st offense: Written Warning 2nd offense: Maximum \$100 fine, plus mandatory suspension of one game 3 <sup>rd</sup> offense: Maximum \$250 fine, plus mandatory suspension of 4 games and possible Season Suspension
Physical assault/abuse of a spectator	1st offense: Maximum \$1000 fine, plus possible suspension of one game. 2nd offense: Maximum \$2000 fine, plus mandatory suspension of 8 Games and possible Season Suspension
Entering the stands – standing on boards, laying on boards, celebrating	1st offense: Maximum \$100 fine, 2nd offense: Maximum \$ 250 fine, plus possible suspension of one game 3rd offense: League suspension 4 games, possible Season Suspension
Entering the stands- fighting, running up stands, conduct detrimental, etc	1 <sup>st</sup> offense- \$5000 2 <sup>nd</sup> offense- \$10000 3 <sup>rd</sup> offense- termination

**Uniform Dress Code Violations**

**Towels.** must be white or in official team colors (yellow, gold and similar colors that might be confused with the game officials' flags are prohibited). Such towels also must be four (4) inches wide and twelve (12) inches long, and must be attached to or tucked into the front waist of the pants. A player may wear no more than one towel. Players are prohibited from discarding on the playing field any loose towels or other materials used for wiping hands or the football. Streamers or ribbons, regardless of length, hanging from

**Stockings.** Mandatory 2-color socks for all Arena Football One teams. Stockings should cover the entire area from the sole to the bottom of the pants and should meet the pants below the knee. Players are permitted to wear as many layers of stockings as they prefer, provided the exterior is the 2-color team provided stocking and in approved team colors. Uniform stockings may not be altered (ie., over-stretched, or cut at the toes or stirrups) in order to bring color lines higher. No other stockings and/or opaque tape may be worn over the one-piece, 2-color uniform stocking. Barefoot place kickers may omit the stocking of the kicking foot in preparation for a during kicking plays.

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

**Head Coverings.** Head coverings worn under the helmet (i.e., sweatbands and bandannas) are permissible and may be visible in the bench area, provided that they are in official team colors and issued by the team, and further provided that no portion hangs from or is otherwise visible outside the helmet during play. Baseball-type caps may be worn in the bench area, provided that they are in official team colors and issued by the team.

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

**Jerseys.** Jerseys should cover all pads and other protective equipment worn on the torso and upper arms. Jerseys must be appropriately tailored to remain tucked into the uniform pants throughout the game. Tear away jerseys are prohibited. Mesh jerseys with large fishnet material (commonly referred to as bullet-hole or porthole mesh) are also prohibited. Surnames of players in letters a Maximum of two and 1/2-inches high must be affixed to the exterior of jerseys across the upper back above the numerals; nicknames are prohibited; and in cases of duplicate surnames, the first initial of the given name must be used. All jerseys must carry a small Arena Football One Logo displayed on the torso of the jersey. Shimmel cut jerseys do not meet League mandates.

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

**Pants.** Pants must be worn over the entire knee area. Pants shortened or rolled up to meet the stockings above the knee are prohibited. No part of the pants may be cut away unless an appropriate gusset or other devise is used to replace the removed material.

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

**Spattng of Shoes.** No spattng allowed. \*Exception: Medical Reasons (documentation to League office necessary). If spattng is allowed, teams with black shoes must tape in black. Teams in white shoes must tape in white. No other color is acceptable. 10-23-02

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

### **Logos and Commercial Identification**

Throughout the period on game day that a player is visible to the stadium and television audience (including in pre-game warm-ups, in the bench area, and during post-game interviews in the locker room or on the field), players are prohibited from wearing, displaying, or orally promoting equipment, apparel, or other items that carry commercial names or logos of companies, unless such commercial identification has been approved in advance by the Arena Football One League Office. The size of any approved logo or other commercial identification involved in an arrangement between a manufacturer and the League will be modest and unobtrusive, and there is no assurance that it will be visible to the television audience (i.e., any approved glove logo will be very small and will appear on only one of the two gloves worn by a player).

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

## Personal Messages

Throughout the period on game day that a player is visible to the stadium and television audience (including in pre-game warm-ups, in the bench area, and during post-game interviews in the locker room or on the field), players are prohibited from wearing, displaying or otherwise conveying personal messages either in writing or illustration, unless such a message has been approved in advance by the Arena Football One League Office. Items such as armbands and jersey patches worn to celebrate anniversaries of events to promote charities, to recognize causes and campaigns, or to honor or commemorate any person are also prohibited unless approved in advance by the Arena Football One League Office.

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

## General Appearance

Consistent with the equipment and uniform rules, players must otherwise present a professional and appropriate appearance while before the public on game day. Among the types of activities that are prohibited are use of tobacco products (smokeless included) while in the bench area and the use of facial makeup. The Referee is authorized to use his judgment in determining whether any other unusual appearance or behavior is in violation of this Section.

1st offense: Written Warning  
2nd offense: \$ 75 fine  
3rd offense: \$150 fine plus one game suspension  
4th offense: \$300 fine, plus possible Season Suspension

Throwing, spiking, or kicking a ball into the stands per game

1st ball: \$100  
2nd offense or more: \$200 each per game

Taking a ball to the bench per game

Handing a ball into the stands per game

Player leaving bench during altercation

Ejected player failing to leave the bench area in a timely manner within 3 minutes

Violence demonstration: Six-guns, Throat Slash, etc.

Taunting: Players fouled for "taunting" will be fined up to the stated amount

Leg Whip: Intentional blow/kick to the opponent will be deemed "with intent to injure an opponent." In addition to a Personal Foul, player will be fined up to the stated amount.

1st ball- \$60 2nd offense or more - \$75  
1st ball- \$60 2nd offense or more - \$75  
Maximum \$250 fine, plus possible suspension  
Maximum \$200 fine

\$250 per occurrence fine max of \$500 per game  
\$75 fine per occurrence max of \$150 per game

1st offense: \$150 fine and one game suspension  
2nd offense: \$300 fine and possible 4 game suspension  
3<sup>rd</sup> offense: \$500 fine plus possible season suspension

Blows to the Head: In addition to a Personal Foul, player will be fined up to the stated amount.

1<sup>st</sup> offense: \$150 fine and one game suspension  
2<sup>nd</sup> offense: \$300 fine and 4 game suspension  
3<sup>rd</sup> offense: \$500 fine plus possible season suspension

Unexcused absences for missing post game autograph session

\$100 per offense

Filing complaint against player or team that is
