



In 2006 Baylor's women's tennis team made program history clinching both conference titles. The Bears went undefeated in regular season play and earned their third Big 12 Championship title (2003, 2005, 2006). And for the first time in program history, the women claimed the Big 12 Tournament Championship trophy with a solid 4-0 victory over Texas in the title match.

After hosting the NCAA Regional tournament, Baylor traveled to the NCAA Championships in Palo Alto, Calif., where the Bears advanced to the Elite Eight round, their deepest postseason run ever. After falling to fourth-ranked Florida, Baylor finished the season ranked sixth nationally, its highest season-ending ranking ever.

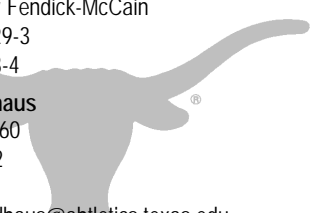

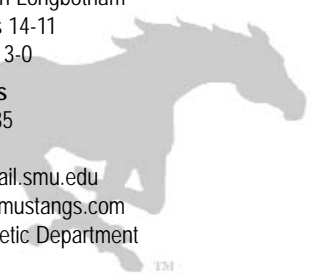
