Bulldogs Battle To 4-3 Win Over USC

Georgia holds serve on its home courts to top the fourth-seeded Trojans.

ATHENS, Ga. — The 12th-ranked, 13th-seeded Georgia Bulldogs fed off a raucous crowd to top Southern California, 4-3, at the Dan Magill Tennis Complex in Athens.

The Trojans flashed early resilience, bouncing back from a court three doubles loss to take the doubles point with wins on the top two courts. The point was sealed with a tiebreaker win on the top court where Brandon Holt and Riley Smith upset the top-ranked pair of Jan Zielinski and Robert Loeb, 7-6(7-1).

Georgia counterpunched in singles play, winning four of the six matches. Veteran Walker Duncan got momentum for the home team with a 6-4, 6-1 win on the fifth court, but Holt then topped SEC Freshman of the Year Nathan Ponwith on the top court to regain the lead for the Trojans, 2-1.

The Bulldogs and Trojans then traded the next two matches, with 59th-ranked Emil Reinberg emerging victorious on court three, 6-2, 7-5, and USC's Riley Smith topping Loeb 3-6, 6-4, 7-5 to snag a 3-2 lead.

Georgia then slammed the door on courts four and two with dominant third-set efforts from Zielinski (7-6, 3-6, 6-3) and Wayne Montgomery (7-5, 6-7, 6-2), respectively, as the pair claimed wins just seconds apart to clinch the match.

The Bulldogs will face the UCLA Bruins on Saturday for a spot in the semifinals.
