Thursday, August 27, 2009

Leave Gerald R. Ford Intl. Airport at 5:35 AM via commercial jet to Amarillo, Texas, where a bus will take us to our hotel in Canyon. We will arrive around noon. You have the afternoon and evening on your own to explore Canyon or visit the West Texas A & M campus.

Friday, August 28, 2009

Cowboy Morning Breakfast in Palo Duro Canyon with the GVSU Laker Football Team. Our bus will pick us up at 8 AM (CST) and take us to the Elkins Ranch located in the canyon, about 20 minutes away from our hotel. Guided jeep tour into Palo Duro Canyon, arrive at Cow Camp and enjoy a down-home delicious, all-you-can-eat chuck wagon breakfast. Following breakfast relax with boot-stompin' cowboy entertainers, poetry, and storytelling. Our bus will bring us back to our hotel around noon.

GVSU Women's Volleyball will play at 1 PM and 7 PM, game tickets are included.
