

Players and Substitutions

- Each team may have up to four players
- Player substitution is permitted during a dead ball situation. Players must check in at the scorer's table prior to entering the game.

Scoring

- A field goal is worth 1 point.
- A successful goal from beyond the 21-foot arc is worth 2 points.
- Points are as followed:
 - Adult Bracket Games: 20 points, win by 2, up to a maximum of 25 points.
 - Junior Bracket Games: 15 points, win by 2, up to a maximum of 20 points
- All games will have a 25-minute time limit.
- The team leading at the end of 25-minute time limit will be declared the winner.
- If the game is tied after 25 minutes of play and no team has reached the required number of points to win the game, the official will flip a coin to determine team possession. The first team to score will win the game.

Live Ball/Dead Ball/Possession

- All jump balls go to the defense.
- The ball must be taken back to the 3-point line on every change possession.
- After all successful shots, the ball must be checked by the defense and passed in by the offense.
- Each team is allowed two (2) one-minute timeouts per game.
- Dunking is NOT allowed
- Player will foul out of the game on his or her sixth personal foul.

Fouls and Free Throws

- Shooting fouls will be handled in the following manner...
 - When the basket is made: whether the ensuing free throw is made or missed, possession goes to the defensive team.
 - When the basket is missed: if the free throw is made, possession goes to the defensive team. If the free throw is missed, the offensive team retains possession.
 - Note:** One (1) free throw will be awarded to the fouled player, even if fouled in the act of attempting a shot behind the 2-point line.
- Non-shooting fouls on or after the seventh team foul will be handled in the following manner...
 - If the free throw is made: possession goes to the defensive team.
 - If the free throw is missed: the offensive team retains possession.

***FREE THROW OPTION:** in any free throw situation, the designated shooter may at his or her option choose to shoot from the free throw line for one point, or from behind the 2-point line for two points. If the 2-point shot is chosen, the non-shooting team will be awarded possession on the ensuing throw-in regardless of whether the shot is successful or not.

Flagrant and Intentional Fouls

- The official may assess a technical foul for misconduct, flagrant or intentional fouls committed by player(s).
- Penalty results as normal foul play
- A technical foul will be counted as a personal and team foul.
- Continuous misconduct, intentional and/or flagrant fouling may result in ejection from the tournament.

Liability Waiver

Every participant, in addition to the player's parent or guardian if player is under the age of 18, must read this waiver form and sign in appropriate space on the registration form. Signatures on the registration form signify each person has read, understands and abides by this information.

As a parent, guardian or participant age 18 or older, I am granting permission for my son, daughter or myself to play in the 3-on-3 Basketball Tournament sponsored by the Men's and Women's Basketball Teams of Lake Superior State University. I understand that there are risks associated with participation in this tournament and its related events. I release and discharge Lake Superior State University from all actions, suits and demands whatsoever in law or in equality including but not limited to the risk of injury from playing in the events and the risk of loss or personal property by theft or otherwise.

As a participant, I agree to play by the rules of the tournament, and I understand that officials reserve the right to eject players from the game and/or school property without refund of paid fees due to rowdiness or disrespectfulness.
