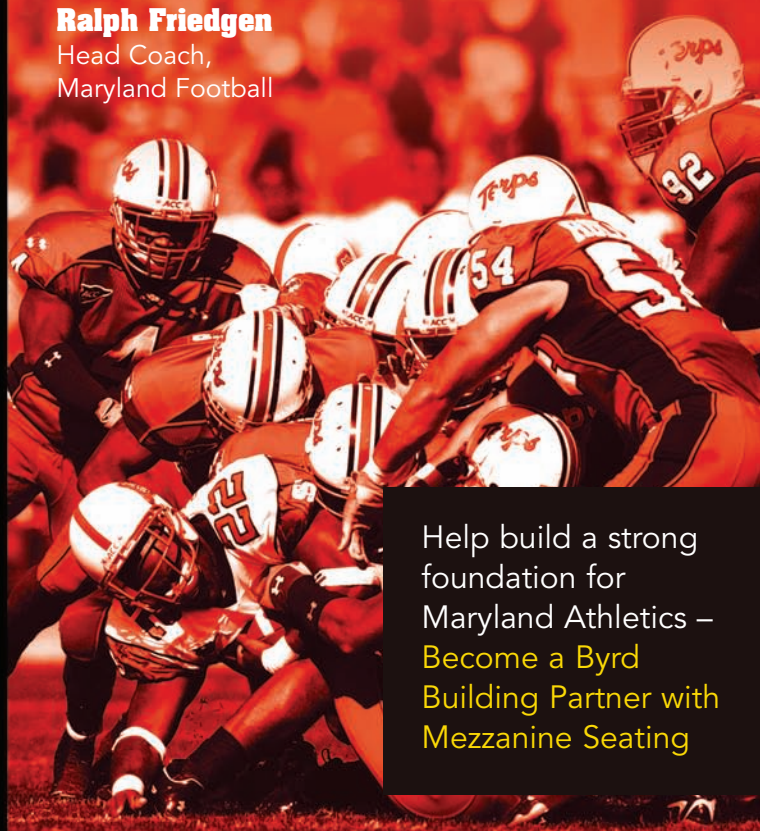

The expansion and renovation of Tyser Tower within Chevy Chase Bank Field at Byrd Stadium is underway. A key component of this project is the construction of 441 new mezzanine seats just under the renovated and significantly expanded Tyser Tower. In the first phase of Byrd Building Partners, donors may gain permanent rights to seats in this new premium mezzanine seating area, as well as a very limited number of seats in the existing mezzanine area in Sections 23, 24, 25, and 26.

Ideally located just under Tyser Tower, the mezzanine premium seating area will feature:

- Private seating area
- Spectacular views of the field
- Premium padded seats
- Complimentary in-seat food and beverage service
- Overhead heaters

MEZZANINE SEATING

Mezzanine seating will be available in nine sections that run the length of Chevy Chase Bank Field. Donors will be able to secure long-term rights to mezzanine seating by making a campaign donation. Donors will have the option of securing seats for the lifetime of the donor and spouse, or 20 years, whichever is longer. There is an additional option for 10-year rights.

Campaign donations for permanent rights will range from \$10,000 to \$30,000 per seat for lifetime rights (depending on location). Campaign donations for 10-year rights will range from \$7,000 to \$21,000 (depending on location). Campaign donations are payable over a five-year period. Terpoints will be awarded for contributions (8 points per \$100 as current gift).

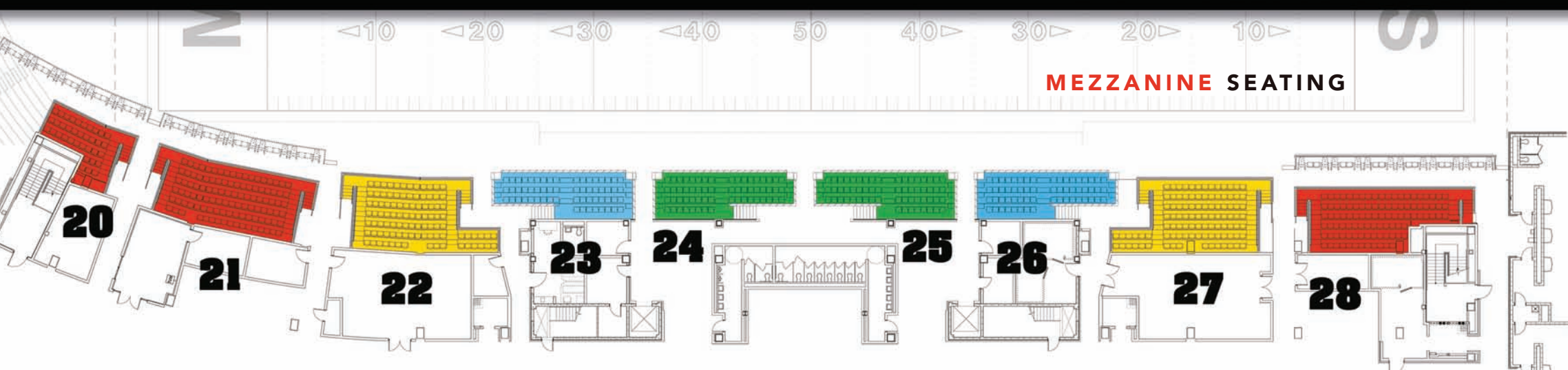

Additionally, donors who secure long-term rights to mezzanine seats must commit to maintaining a minimum annual Terrapin Club donation at the Super Terp or higher level (depending on the number of desired seats).

Campaign donors for Byrd Building Partner Mezzanine seats will qualify for numbered reserved parking (1 space per 4 seats); the location will be based on the donor's annual giving level and Terpoint priority rank combined.

Commitments for this campaign will be accepted on a first-come, first-served basis (with the exception of seats in Sections 23, 24, 25, and 26; current seat holders in these sections have first right of refusal). However, seat assignments for Byrd Building Partners Mezzanine Seating will be determined in Terpoint priority rank order (as of March 31, 2009) within the appropriate section for their campaign gift level.

Mezzanine seats are scheduled to be available for use beginning with the 2009 season. During the 2009 season, we will play a home schedule of ACC schools that include Virginia, Virginia Tech, Clemson, Boston College as well as three big non-conference foes including Rutgers, Middle Tennessee State and James Madison.

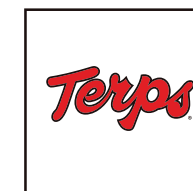
