## Stanford Atop Division I Learfield Sports Directors' Cup Standings; ACC Places Four Institutions in Top 10

**CLEVELAND** – **Stanford** remains in first place in the third fall Learfield Sports Directors' Cup Standings with 310 total points. The Cardinal won the national championship in women's soccer, placed fifth in men's cross country, ninth in field hockey, 10<sup>th</sup> in women's cross country and 17<sup>th</sup> in volleyball.

**North Carolina** is in second place with 304 total points. The Tar Heels captured the men's soccer national championship, finished in second place in field hockey, ninth in women's soccer and 17<sup>th</sup> in volleyball.

Just behind in third place, with 303 total points, is **UCLA**. The Bruins won the volleyball national championship, finished second in men's water polo, third in men's soccer and 17<sup>th</sup> in women's soccer.

**Florida State** occupies the fourth spot with 300 total points. The Seminoles earned third place finishes in women's soccer and volleyball, a fourth place finish in women's cross country and placed 12<sup>th</sup> in men's cross country.

Rounding out the top five is **Penn State**. The Nittany Lions' fifth place finish in field hockey, ninth place finishes in women's soccer and volleyball and 13<sup>th</sup> place finish in women's cross country gives them 239 total points.

Six of the seven fall NCAA championships have been completed with the following institutions capturing titles: men's cross country – Wisconsin; women's cross country – Georgetown; women's soccer – Stanford; men's soccer – North Carolina; field hockey – Maryland; and men's water polo – Southern California; volleyball – UCLA.

The **ACC** has two institutions in the top five and four institutions in the top 10 – North Carolina (2<sup>nd</sup>), Florida State (4<sup>th</sup>), Maryland (6<sup>th</sup>) and Duke (7<sup>th</sup>). The **Pac-12** placed two institutions in the top five and three in the top 10 – Stanford (1<sup>st</sup>), UCLA (3<sup>rd</sup>) and USC (10<sup>th</sup>).

The Learfield Sports Directors' Cup was developed as a joint effort between the National Association of Collegiate Directors of Athletics (NACDA) and *USA Today*. Points are awarded based on each institution's finish in up to 20 sports -- 10 women's and 10 men's.

The final fall Division I standings will be released Thursday, January 12, 2012.
