Stanford Finishes Fall Atop Division I Learfield Sports Directors' Cup Standings; ACC Places Four Institutions in Top 10

CLEVELAND – **Stanford** remains in first place in the final fall Learfield Sports Directors' Cup Standings with 382 total points. The Cardinal won the national championship in women's soccer, placed fifth in men's cross country, seventh in FBS football, ninth in field hockey, 10th in women's cross country and 17th in volleyball.

Florida State is in second place with 351 total points. The Seminoles finished third in women's soccer and volleyball, fourth in women's cross country, 12th in men's cross country and 23rd in FBS football.

In third place, with 329 total points, is **North Carolina**. The Tar Heels captured the men's soccer national championship, finished second in field hockey, ninth in women's soccer, 17th in volleyball and 44th in FBS football.

Just behind in fourth place with 328 total points is **UCLA**. The Bruins earned a first place finish in volleyball, second in water polo, third in men's soccer and 44th in FBS football.

Rounding out the top five is **Michigan**. The Wolverines fifth place finish in women's field hockey, ninth place finishes in volleyball and FBS football and 15th place finish in women's cross country accumulated 272 points.

All fall NCAA championships have been completed with the following institutions capturing titles: men's cross country – Wisconsin; women's cross country – Georgetown; women's soccer – Stanford; men's soccer – North Carolina; field hockey – Maryland; and men's water polo – Southern California; volleyball – UCLA, FBS football – Alabama and FCS football – North Dakota State .

The **ACC** has two institutions in the top three and four institutions in the top 10 – Florida State (2nd), North Carolina (3rd), Maryland (8th) and Duke (9th). The **Pac-12** placed two institutions in the top five – Stanford (1st) and UCLA (4th).

The Learfield Sports Directors' Cup was developed as a joint effort between the National Association of Collegiate Directors of Athletics (NACDA) and *USA Today*. Points are awarded based on each institution's finish in up to 20 sports -- 10 women's and 10 men's.

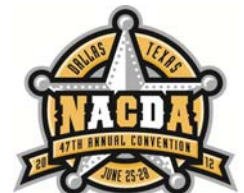
The first winter Division I standings will be released Thursday, March 22.
