Azusa Pacific Remains in Lead in Final Winter NAIA Learfield Sports Directors' Cup Standings

Cleveland, Ohio – Azusa Pacific maintains its lead of the NAIA Learfield Sports Directors' Cup standings with 661 total points. The Cougars placed ninth in Division I women's basketball and 17th in Division I men's basketball to bring their winter total to 337 points. Azusa Pacific's other scores this winter came in men's indoor track and field, where it placed first, women's indoor track and field, where it finished second and women's swimming where they placed seventh.

Lindenwood remains in second place with 578.50 points. This winter, the Lions captured the men's wrestling title, placed sixth in women's indoor track and field, seventh in men's swimming, eighth in women's swimming and 11th in men's indoor track and field bringing their winter point total to 374.50 scoring the most of any institution.

Concordia (Calif.) also holds onto third place in the final winter standings. The Eagles have a total of 514.50 points, with 333.50 coming during winter. Concordia placed fifth in Division I men's basketball and earlier this winter finished third in men's swimming, sixth in women's swimming, 19th in indoor women's track and field and 21st in men's indoor track and field.

Fresno Pacific remained in fourth place after notching a 17th place finish in Division I men's basketball for a total of 465 points. Earlier this winter, the Sunbirds placed second in men's swimming, fourth in women's swimming, 17th in men's indoor track and field and 36th in women's indoor track and field.

Ascending into the top-five in the final winter standings is Black Hills State (S.D) who jumped from 10th to fifth. The Yellow Jackets placed third in Division II men's basketball and placed fifth in Division II women's basketball. Black Hills State also finished eighth in women's indoor track and field and 28th in men's indoor track and field bringing them to 428.75 total points.

Nine winter NAIA championships have been completed to date with the following institutions capturing titles: Union (Tenn.) (Women's Division I Basketball); Rocky Mountain (Men's Division I Basketball); Morningside (Iowa) (Women's Division II Basketball); Oklahoma Wesleyan (Men's Division II Basketball); Savannah Art & Design (Ga.) (women's swimming); California Baptist (men's swimming); Wayland Baptist (Tex.) (women's track & field); Azusa Pacific (Calif.) (men's track & field); and Lindenwood (Mo.) (men's wrestling).

The Learfield Sports Directors' Cup was developed as a joint effort between the National Association of Collegiate Directors of Athletics (NACDA) and *USA Today*. Points are awarded based on each institution's finish in up to 12 sports – six women's and six men's.

The first spring NAIA standings will be released Thursday, May 28, 2009.

Please note, standings published midseason are unofficial. Official standings will be published upon the completion of the spring season. Complete standings and the scoring structure can be found on NACDA's Web site at www.directorscup.org.
