Grand Valley State (Mich.) Keeps Top Spot in the Final Fall Division II Learfield Sports Directors' Cup Standings

Cleveland, Ohio – Grand Valley State (Mich.) remains atop the final fall Learfield Sports Directors' Cup standings with 380 points. The Lakers finished in the top 10 in four of the five championships they qualified for – women's soccer, first; football and women's cross country, second; and men's cross country, fifth. They also finished 33rd in women's volleyball.

Minnesota Duluth enters the top five with 239 points. The Bulldogs finished fifth in football, seventh in women's cross country and 17th in both women's soccer and women's volleyball.

Carson Newman (Tenn.) is in a close third with 231 total points, after finishing third in men's football, fifth in women's soccer and 17th in men's soccer and women's volleyball.

California (Pa.) jumped from 18th to fourth in the final set of fall standings with a total of 229 points. The Vulcans finished third in the Division II Football Championship and fifth in women's soccer and women's volleyball.

Rounding out the top-five is West Texas A&M with 216 points. The Buffs placed second in women's volleyball, fifth in women's soccer and ninth in men's soccer.

All seven fall NCAA championships have been completed with the following institutions capturing titles: Adams State (men's and women's cross country); Bloomsburg (Penn.) (women's field hockey); Grand Valley State (women's soccer); Fort Lewis (Colo.) (men's soccer); Concordia (Minn.) (women's volleyball); and Northwest Missouri State (football).

The Learfield Sports Directors' Cup was developed as a joint effort between the National Association of Collegiate Directors of Athletics (NACDA) and *USA Today*. Points are awarded based on each institution's finish in up to 14 sports -- seven women's and seven men's.

The first Division II winter standings will be released Thursday, March 18, 2010.

Please note, standings published midseason are unofficial. Official standings will be published upon the completion of the spring season. Complete standings and the scoring structure can be found on NACDA's Web site at www.nacda.com.
