WAIVER-SPIKER CLINICS; RELEASE AND INDEMNIFICATION AGREEMENT

In consideration of the University's agreement to permit my son(s) or daughter(s) to participate in the Irish Spiker's Volleyball Club (the "Club"), I agree as follows: I, individually, and on behalf of my minor child (or children) hereby release, acquit and forever discharge and agree to indemnify, defend and hold harmless, the University of Notre Dame (the "University"), and their employees, agents, servants, officers, trustees and representatives (in their official and individual capacities) from any and all liability whatsoever for any and all damages, losses or injuries, including death, to persons or property or both including but not limited to any claims, demands, actions, causes of action, damages, costs, expenses, and attorneys fees, which arise out of, during or in connection with my child's (or children's) participation in the aforementioned Club, including by not limited to any damages, losses or injuries to persons or property or both, which may be sustained or suffered by my child or any person in connection with my child's (or children's) association with, or participation in, activities at, sponsored by, or arising out of his or her travel to or from the University.

I hereby acknowledge and accept that there are certain risks arising from volleyball activities, including bodily injury and death, that could result from my child's (or children's) participation in the aforementioned Club activities at the University. I have knowingly and voluntarily decided to assume the risks of these inherent dangers in consideration of the University's permission to allow my minor child (or children) to participate in the aforementioned Club.

In signing this Waiver, Release, and Indemnification Agreement, I hereby acknowledge and represent that I have read this entire document, that I understand it affects my legal rights and those of my child (or children), that it is a binding Agreement, and that I have signed it knowingly and voluntarily.
