Please review and affirm your understanding of the policies by signing below:

NCAA Rules:

- ☞ A coach, staff member or booster **may not** provide a student-athlete or prospect with the use of a vehicle. The host is expected to use his/her own vehicle or a teammate's for entertaining the prospect.
- ☞ Texas **may** provide only **one** student-athlete host per prospect with a meal only if they are accompanying the prospect on the meal.
- ☞ Texas **may** provide a host with a maximum of \$30 for each day of the official visit to cover the actual costs of entertaining the prospect (and the prospect's parents, legal guardian or spouse).
- ☞ These or other funds **may not** be given to the prospect or used for the purchase of souvenirs.
- ☞ The student host **may** be provided a complimentary admission to accompany the prospect to an institution's home athletic contest.
- ☞ The institution **may** provide reasonable entertainment within **30-miles** of the institution's campus to the prospect, their parents or legal guardians and spouse only. It is not permissible to entertain siblings, friends or other guests of the prospect.

Conduct:

- ☞ NCAA rules **must** be abided by all persons in all situations (see above). If at any time a student-athlete is uncertain of NCAA rules, he/she is to contact the coaching staff immediately.
- ☞ Individuals involved in the recruiting visit (including the prospect) are expected to act in a responsible manner and to abide by the law. **The use of alcohol, drugs, sex and gambling in recruiting are strictly prohibited. This includes being under the influence of alcohol or drugs at any time while you are hosting a prospect during his/her recruiting visit.**
- ☞ Any consumption of alcoholic beverages or drugs (underage drinking is against the law) is strictly prohibited during the official visit by all individuals involved in the recruiting visit.
- ☞ The use of any type of "adult entertainment" (i.e., exotic dance clubs, escort services) is strictly prohibited in recruiting.
- ☞ A prospect is **never** to be left alone or with a non-team member (e.g., Texas Recruiter) or to be arranged a date or other encounter that could lead to inappropriate behavior (e.g., sexual misconduct, use of alcohol, drugs, etc.).
- ☞ A student-athlete is to follow any additional rules set by your coach (e.g., curfew, team policies, etc.).

TO BE COMPLETED BY THE STUDENT-HOST:

I certify that I reviewed and had the above instructions explained by the athletics compliance office and/or my coaches prior to me hosting this prospect. I agree that I was provided the opportunity to ask any questions I have regarding my hosting of any prospective student-athlete. I understand that I am responsible for the prospect while on our own during his/her official visit and agree to contact my coaches or athletics compliance office with any questions should they arise. As the designated student host I must conduct myself in a manner that is consistent with university principles and that does not violate any state and/or federal laws, and NCAA or University of Texas regulations. If I conduct myself in a manner which is deemed to be detrimental to the Texas Department of Athletics, I understand the Texas Department of Athletics may take corrective action and I may jeopardize my eligibility.
