

## TITLE IX COORDINATOR

**“No person in the United States shall, on the basis or sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance...”**

**20 U.S.C. § 1681**

Title IX of the Education Amendments of 1972 (Title IX) prohibits discrimination based on gender in educational programs which receive federal financial assistance. Athletics are one component of Title IX. Other programs and activities which may be included are: recruitment, admissions, financial aid, and scholarships; course offerings and access; hiring and retention; and benefits and leave. Title IX also protects students and employees, both male and female, from unlawful sexual harassment in school programs and activities.

Pursuant to Title IX of the Education Amendments of 1972 and 34 C.F.R. Part 106, The University of Tulsa’s Title IX Coordinator is the designated agent of the University with primary responsibility for coordinating University Title IX compliance efforts. The Title IX Coordinator’s responsibilities are critical to the development, implementation, and monitoring of meaningful efforts to comply with Title IX legislation, regulation, and case law. The Title IX Coordinator oversees monitoring of University policy in relation to Title IX law developments; implementation of grievance procedures, including notification, investigation and disposition of complaints; provision of educational materials and training for the campus community; conducting and/or coordinating investigations of complaints received pursuant to Title IX; ensuring a fair and neutral process for all parties; monitoring all of other aspects of the University’s Title IX compliance.

*Individuals with questions or concerns about Title IX, and/or those who wish to file a complaint of non-compliance, may contact the University’s Title IX Coordinator. Anyone that who has a complaint (regardless of whether it’s against a student, staff, faculty visitor, or otherwise), should feel free to contact the Title IX Coordinator, Wayne Paulison, directly if for any reason they are uncomfortable about initiating a complaint with the designated Deputy Coordinator.*

*The University of Tulsa has grievance procedures for anyone who is dissatisfied with how her/his case was handled by someone within the Title IX complaint system.*
