## TAX INFORMATION:

- (1) Donations are fully tax deductible less the value (good faith estimate) of any benefits received.
- (2) Must elect if desired. Specifies number of complimentary season tickets and/or pass issued with your membership. The value of complimentary tickets/pass does reduce your tax deduction. You may elect not to receive complimentary tickets/pass by notifying the club or ticket office.

NOTES:

- A) Access to Priority Seating for Men's Basketball.
- B) Inner lot of Reynolds Center (SE side), controlled and attended.
- C) No parking pass issued to Booster Club level (Red lot). Red lot is unattended.
- D) Number of complimentary meal credits. Requires 631-GOLD RSVP. Meal credits are transferrable / assignable. Once meal credits are used (no further credits in account) additional meals can be purchased at published GHC rate.
- E) Must elect if desired. Coaches Club members receive 2 tickets for the price of 1.
- F) Must elect if desired. Olympic Family Pass (\$50 value) / Booster Club members receive 50% discount. Includes admittance for a family of four (2 adults, 2 children) to any home volleyball, women's softball, men's and women's soccer and men's and women's tennis game/match.
- G) Presidents Council requires a minimum \$1,500 donation. Members receive invitations to special university sponsored events.
- H) Special locker room access, special game day access, special social opportunities... exact offerings to be determined and customized by GHC on an annual basis.
- I) Prime location across from Skelly Stadium. Contact GHC office.
- J) Travel with FB team for 2, maximum 1 trip annually, limited space, destination preselected by GHC.
- K) Travel with MBB team for 2, maximum 1 "road trip" annually, limited space, destination preselected by GHC.
- L) Must elect if desired. Specify item and size on Membership Form. Represents number of outerwear / apparel items offered. Select from warmups, jackets, polo shirts, hats depending upon club level.
- M) Must elect if desired. FB, MBB & WBB only. Bronze Cane and below (\$5,999 or less) may purchase media guides at \$10 each.
