



You must provide identity and work eligibility documents as noted below. We can only accept the **original** document. **COPIES ARE NOT ACCEPTABLE.** **All documents must be unexpired.** You will need to present either one of the following documents from List A **OR** one of the following documents from List B **AND** one of the following documents from List C. If you are a Permanent Resident you are required to bring your **green card**. If you are an alien authorized to work, you will also need to provide your alien card and/or **passport + work authorization + social security card**.

List A

Documents that establish both identity and employment eligibility

- **Unexpired** United States Passport
- Permanent Resident Card or Alien Registration Receipt Card (Form I-551)
- **Unexpired** foreign passport that contains a temporary I-551 stamp or a temporary I-551 printed notation on a machine-readable immigrant visa.
- **Unexpired** Employment Authorization Document issued by the DHS which contains a photograph (**INS Form I-766**)
- In the case of a nonimmigrant alien authorized to work for a specific employer incident to status, an **unexpired** foreign passport with Form I-94 or Form I-94A bearing the same name as the passport and containing an endorsement of the Alien's nonimmigrant status, as long as the period of endorsement has not yet expired and the proposed employment is not in conflict with any restrictions or limitations identified on the form. (**The Form I-94 for F-1 non-immigrant students must be accompanied by an I-20 form indicating UCLA as the sponsoring school. Also, the Form I-94 for J-1 nonimmigrant exchange visitors must be accompanied by an unexpired DS-2019 form. If UCLA is not the J-1 sponsor, written approval from the sponsoring authority is required. The sponsoring authority is the responsible officer who has authority to sign the DS-2019.**)
- **Unexpired** Passport from the Federated States of Micronesia (FSM) or the Republic of the Marshall Islands (RMI) with Form I-94 indicating nonimmigrant admission under the Compact of Free Association Between the United States and the FSM or RMI

List B

Documents that establish identity only

- **Unexpired** Driver's license or ID card issued by a state or outlying possession of the United States provided it contains a photograph or information such as name, date of birth, gender, height, eye color and address
- **Unexpired** ID card issued by federal, state or local government agencies or entities, provide it contains a photograph or information such as name, date of birth, gender, height, eye color and address
- **Unexpired** School ID card with a photograph
- Voter's Registration Card
- US Military card or draft record
- **Unexpired** Military dependent's ID card
- **Unexpired** US Coast Guard Merchant Mariner Card
- Native American tribal document
- **Unexpired** Driver's license issued by a Canadian government authority.

List C

Documents that establish employment eligibility only

- Social Security Card issued by the Social Security Administration without employment restrictions (**Laminated cards are NOT ACCEPTABLE**)
- Certification of Birth Abroad issued by the Department of State (**Form FS-545**)
- Certification of Report of Birth issued by the Department of State (**Form DS-1350**)
- Original or certified copy of a birth certificate issued by a State, county, municipal authority or territory of the United States bearing an official seal
- Native American tribal document
- U.S. Citizen ID Card (**INS Form I-197**)
- ID Card for use of Resident Citizen in the United States (**INS Form I-179**)
- **Unexpired** employment authorization document issued by the DHS (**other than those listed under List A**)

(Sample documents would include: Certificate of Naturalization, Notice of Action (I797) with UCLA listed as sponsor, DS-2019 or I-20.)

- **Unexpired** employment authorization document issued by the DHS (**other than those listed under List A**)
