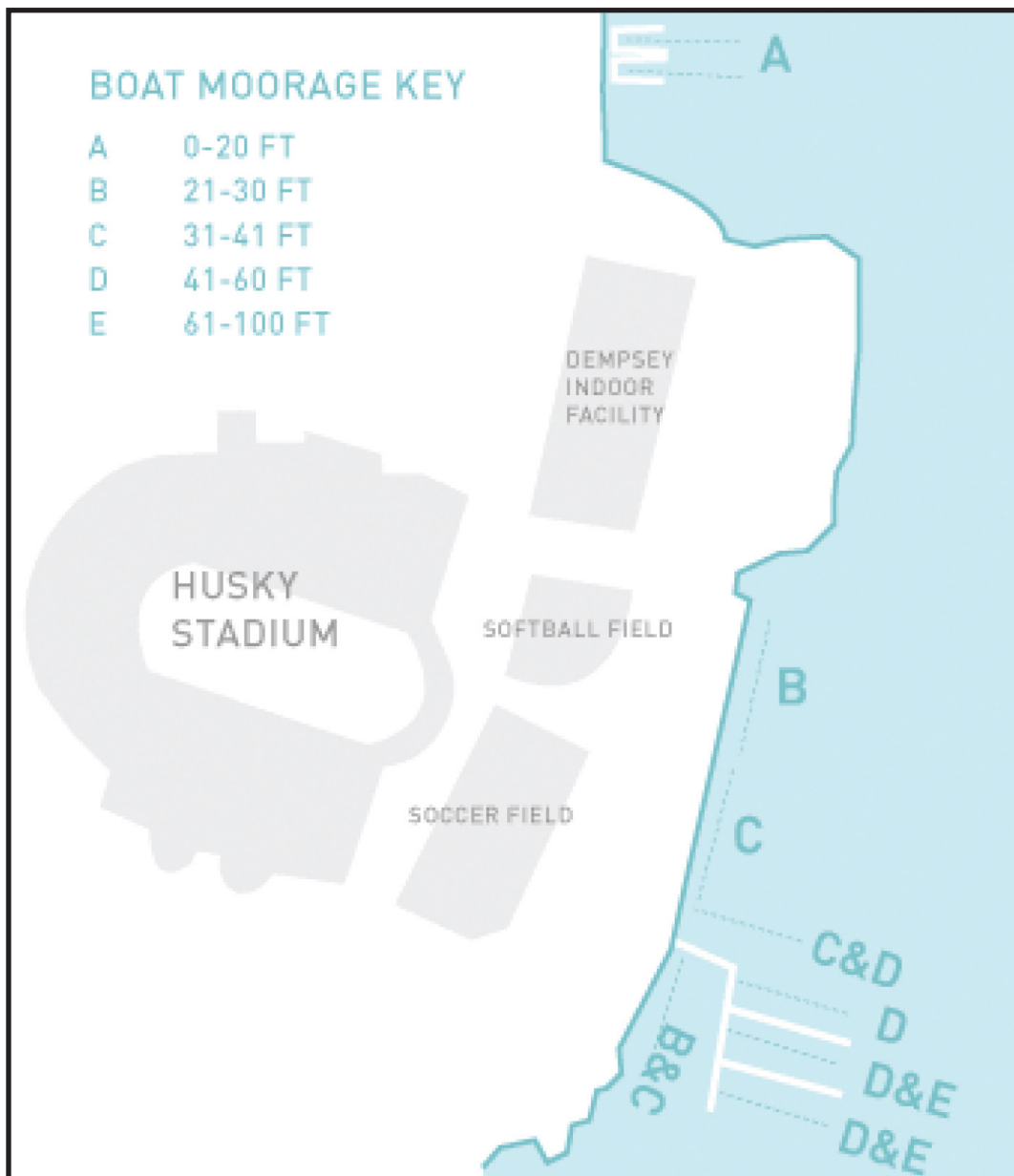

## Purchasing a Boat Moorage Permit

- Moorage permits are sold, issued, and collected through the Tye Club for season passes and individual games and must be purchased before game day.
- Docks open 4 hours prior to kick-off. Please arrive within your assigned time frame.
- Moorage locations are assigned based on first come, first serve.
- Applications for single game permits must reach the Tye Club at least one week before the permit is needed in order to distribute the permit before game day.
- Only those boats displaying a valid moorage permit will be permitted to the boat moorage area and provided a moorage space on football game day.
- Applications for full season permits should be returned by July 1st.
- Moorage permit applications are available in May and will be mailed out in August.
- The UW and the Tye Club are not responsible for lost or stolen permits.
