2. Have alcohol purchased/given for/to me at anytime.
3. Engage in any gambling/gaming activities or any activities that violate criminal law.
4. Receive transportation to and from the campus in excess of my actual round-trip transportation costs on a direct route between my house (or site of my athletics' competition or educational institution) and the institution's campus.
5. Receive cash for entertainment purposes.
6. Receive souvenirs (i.e., t-shirts or other institution mementos) purchased by a student host or other institutional mementos) purchased by a student host or other institutional representatives.
7. Receive any free or reduced-cost athletic gear.
8. Receive an automobile for my personal use.
9. Have any in-person recruiting contact (except an exchange of greetings) on or off-campus with a booster. (No contact is permitted, to include an exchange of greetings, within an athletic facility or while at the institution's athletic banquet.)
10. Receive transportation or entertainment outside 30 miles of the institution's campus.
11. Participate in physical workouts or other recreational activities that were organized or observed by the coaching staff or designed to test my athletic ability.
12. Receive paid expenses for my return trip home after remaining in the institution's locale after the 48-hour visit expired.
13. Receive "hard tickets" to the institution's athletics contest during the visit (can only enter through a pass gate and receive a "stub" for seat identification).
14. Receive complimentary or reduced-cost admissions from the institution for an NCAA championship (all rounds) or post-season football game.
15. Receive reimbursement of my travel expenses (automobile mileage, airfare parking, meals or lodging) to and from the campus that were excessive in nature.
16. Receive any reimbursement or cost-free transportation, lodging, or meals for friends or family members other than my parent(s), legal guardians(s) or spouse.
